B) Reference No. of inquiry letter.
C) Due & opening date of quotation.
D) Rates should be quoted only for single battery
- 02 Sales tax where ever leviable and intended to be claimed from the purchaser should distinctly be shown along with the material quoted in the attached list. Where this is not done, no claim for sales tax will be admitted at any stage and any ground. What so ever 'D' Form will be supplied by this office with purchase order.
- 03 The quotation will be opened in the office of undersigned at 3.00 PM on 28-02-17 in presence of tenderers or the agents as may choose to attend.
- 04 While sending quotation you have to give warranty/guarantee of two year in writing. In case any battery fails to work within warranty/guarantee period, you will be liable to replace the defective battery free of cost.
- 05 If the supply order is placed to your firm, only 90% payment of estimate will be released after the satisfactory delivery of goods in question and 10% of estimate cost will be retained as security money by the Station for one year. No other cartridge charges will be paid for carrying goods etc. at the site.

The quotation submitted, will remain opened for acceptance for a minimum period of three months from the date of its opening. However, this office shall reserve right to accept any quotation not necessarily the lowest or reject all without assigning any reason.
